- 1) Tuition is based on approximately 165 school days from Aug-May.
- 2) **The deposit is due upon registration and is NON-REFUNDABLE.**
- 3) The single payment option is only available before June 1.
- 4) Deferred payments must be paid to F.A.C.T.S. Tuition Services.
- 5) There is a 5% multiple sibling discount applied to the balance after the first child.
